Autumn 2017 – **Senior Graduate Teaching Assistant** on POLI20961 Challenges to Democratic Politics at the University of Manchester

This course analyses the problems faced by contemporary democracies and classical democratic theory’s inability to provide complete answers to them. This course takes a bottom-up approach to problems such as health and educational inequality, the refugee crisis, the erosion of democratic participation mechanisms and Universal Basic Income. As part of the role of Senior Graduate Teaching Assistant I conducted peer reviews of fellow TAs and contributed to course administration.

Spring 2017 and Spring 2018 – **Graduate Teaching Assistant** on POLI10702 Introduction to Political Theory at the University of Manchester

This course introduces students to normative political theory as part of their Politics Philosophy and Economics (PPE) degrees. This course tackles the problem of the legitimacy of States. In particular students consider: i) whether and why states have a right to rule, ii) over whom they should rule and iii) whether legitimacy constrains how states should rule.

Autumn 2015 and Autumn 2016 — **Graduate Teaching Assistant** on POLI20961 Challenges to Democratic Politics at the University of Manchester

This course analyses the problems faced by contemporary democracies and classical democratic theory’s inability to provide complete answers to them.
